TENDER CONDITIONS

- The tenderer shall quote his rate as NIT and Terms & Conditions enclosed in the tender document.
- 2. The interested bidder may examine the nature of work available in STRIVE Cell of ITI Nagaon and visit the site to satisfy them about the scope of work before submitting the tender so as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The contractor shall also abide by the provisions of the Child Labour (Prohibition and Regulation) Act, 1986 and other labour laws. Any failure to fulfil this requirement shall attract the penal provisions of this contract arising out of the resultant no execution of the work. No labour below the age of fourteen years shall be employed on the work.
- During Opening of tender only representative duly authorized by the agency / contractor will be allowed to be present.
